Project Requirements

Cat Project members who intend to exhibit their animal(s) at the Adams County Fair must complete the following to remain eligible for fair entry and exhibition:

- Enroll in the Cats Project by the enrollment deadline..
- Complete and file an Animal Care and Housing Form on 4HOnline by deadline.
- ID all animals in 4HOnline by May 1 deadline (project cat must be owned by ID deadline)
- Attend Animal Record Book Interviews and present an up-to-date E-Record Book.
- Enter fair classes online by deadline.
- Your cat must meet the vaccination requirements to be eligible to enter in the County Fair. (see premium book)
- Complete and turn in Record book the Friday before Labor Day to the Extension Office.

Project Tips - Cats

Additional Information - Animal Entry in 4hOnline

1. 4-H members are required to enter their animals in the 4hOnline enrollment system. This page will help summarize the information required in this system.
2. All Cat project animals must be entered in the 4hOnline system no later than May 1st of the current project year.
3. It is highly recommended any and all animals with the potential of attending Fair have ID in 4hOnline. If an animal does not have ID, it will not be allowed at Fair.

1. Sign up for 4-H Fourcast Newsletters
2. Attend club meetings & meet your club's cat leader & other cat members
3. Order the cat project manual through your Club Leader to help you learn
4. Download the Companion Animal E-Recordbook
5. Review Fair premium book to understand show rules and classes
6. Attend required and optional club and county workshops to learn
7. Work on Companion Animal E-Recordbooks regularly.
8. When in doubt, contact the 4-H office with questions
